Dear Friends of the Foundation:

Since 1989, The Community Foundation of South Puget Sound has assisted individuals, families and businesses in realizing their philanthropic dreams. The Foundation is home to more than 75 individual funds serving Thurston, Mason and Lewis counties. Funds are overseen by our board of directors, a dedicated group of local leaders who ensure that funders' charitable directives are achieved over time and through changing circumstances.

At the close of 2007 The Foundation's asset base approached six million dollars, triple that of three years ago. We continue to achieve good financial returns on our investment portfolio, with excellent investment management and an active, involved finance committee.

In 2007 The Foundation established Disaster Relief Funds in response to the December wind and rain storms. Contributions to these funds, more than \$195,000 to date, will be distributed locally to help families and farmers struggling to recover their homes and livelihoods. Tom and Michele Hulbert initiated a broad-based effort to raise funds for Boistfort Valley flood victims, and the Seattle and Medina Foundations added a combined total of \$40,000 to our Foundation's disaster relief funds.

Also during 2007, we entered into an historic partnership with United Way of Thurston County to assist them in developing their endowment. They have selected The Foundation to be the perpetual community-based custodian of their endowment funds.

We could not have achieved these milestones without the commitment of our board of directors. During 2007, three distinguished board members 'retired' following a combined 21 years of generous service to The Foundation. Brian Fluetsch served 11 years, and will be remaining as a member of our finance committee. David Hayes served six years in service to The Foundation and Sally Warjone provided four years of dedicated service. All three of them gave tirelessly from their stores of leadership and compassion to serve the community through The Foundation.

Three new board members began service in 2007: Dennis Adams, Janet Pearson and Don Rogers, MD. Their knowledge of the community and business expertise will support our future growth and awareness of local needs.

The Foundation's expertise is matching your donations to causes that align with your ideals. Children, health, the environment, conservation, animals, education... the causes are as varied as our donors. We maintain a constant awareness of our community's needs and use our expertise to innovatively match needs with donors' interests.

Collaborates with other organizations to address community needs and objectives.


The Community Foundation's Funds are Organized into Six Types:

Community Funds

These are unrestricted, discretionary monies used to fund grants. These funds provide the greatest flexibility to the Foundation in its goal of responding to disparate and unforeseen needs. Income from these funds is used to award competitive grants in the areas of human services, health, the arts, education, the environment and conservation, the needs of the elderly and many others. A grants committee, comprised of board and community members, meets twice a year to review proposals and recommend funding.

Field of Interest Funds

Field of interest funds support areas of special concern to the donors. Donors can direct The Foundation to award grants within defined spheres of interest such as the arts, education, the environment, historic preservation or health.

Donor Advised Funds

These allow donors to actively participate in the grant making process. Such funds can either be endowed or one in which principal is expended. Disbursement recommendations can be made at any time.

Scholarship Funds


Donors assist deserving students in addressing the financial needs of post-secondary education. A scholarship fund can be very rewarding for the donor who, if they desire, may determine the criteria for the scholarship and participate in the recipient selection process.

Designated Funds

Designated Fund income is specified by donors to be given regularly to named charitable organizations. Through a designated endowment, donors can be assured that their endowment will provide grants to organizations of their choosing for years to come.

Agency Endowments

Nonprofit agencies establish these funds to serve as a perpetual source of income. They choose to locate them within The Foundation to ensure that their endowment will be administered with expert oversight by the Foundation's board and staff whose ultimate objective is to benefit the communities they serve.

Funds Created to Support Disaster Recovery

In response to the December 2007 wind and rain storms in Lewis, Mason and Thurston counties, The Community Foundation established two Disaster Relief Funds. The Community Foundation Relief Fund and the Boistfort Valley Flood Relief Fund were created as mechanisms to receive and disperse contributions. The two funds have distributed over \$150,000 to local families and farmers struggling to recover from millions of dollars in storm damage. Monies were also awarded to community centers providing disaster command center services. Tom and Michelle Hulbert led efforts to raise the majority of the Boistfort Valley relief funds.

Areas hardest hit included Lewis County's Boistfort Valley and Belfair/Tahuya in Mason County. Foundation staff has worked with many community agencies and leaders to award funds to those hardest hit by the storm.

We continue to monitor the storm-affected communities in order to support their long-term disaster recovery needs. We are working to strengthen our community's disaster response by sharing information, simplifying access to available resources and resolving unmet needs. Both Lewis and Mason counties have formed long-term recovery organizations, assisting those with unmet flood recovery needs.

In 2006, The Community Foundation made a donation to north Mason County's Theler Community Center. The grant supported purchase of a large shipping container used to store disaster supplies. When the December 2007 storms hit, Theler Center Executive Director Anne Whitman recalls, "We had the emergency container fully stocked with supplies and when Theler Center was activated as an emergency shelter we were ready to respond to those in need within five minutes."

Foundation Supports Safety

When Centralia Rotary President Melody Nelson chose the project for her year as president, she responded to a vital community need. The Lewis County Sheriff's Office (LCSO) had been without a K-9 team since 2003 and the county's rural character made it imperative to have a certified K-9 team readily available to ensure public safety. President Nelson offered to raise start-up costs and one year's operating expenses – a total of \$50,000 – for a new K-9 program.

K-9 teams allow deputies to perform dangerous tasks, such as evidence retrieval and building searches, in a quick, safe manner. K-9 teams also provide positive interaction between law enforcement officers and the community, especially with children, and are frequently used to locate fleeing crime suspects. But funding for a new K-9 team was not within the sheriff's office's tight budget,

requiring the LCSO to borrow the Centralia Police Department's K-9 unit and handler, for a fee, whenever K-9 support was required.

Nelson and the Centralia Rotary Foundation applied to The Community Foundation to support the K-9 project. With grant assistance from The Community Foundation, and other fund raising spearheaded by the Centralia Rotary Foundation, the Lewis County Sheriff's Office was able to acquire "Leko," a 17-month-old German Shepherd. The dog's name means "buddy" in Hawaiian.

K-9 Leko, and his law enforcement partner Deputy Gabe Frase, subsequently attended a 10-week canine academy involving over 400 hours of training. Leko was officially sworn into active service in late 2007. Then, on Monday, March 10, 2008, Leko's training paid off when he made his first capture. Leko trailed a fleeing suspect through 100 yards of thick brush and located him, resulting in the suspect's prompt capture and arrest.

Deputy Frase is a native of Lewis County, a Marine Corps veteran, a second generation law enforcement officer, and a five-year LCSO veteran. Leko is now an official member of the Frase family, residing with Deputy Frase and his wife, Julie, a corrections sergeant for the Sheriff's Office.

Charneski Funds Make Holiday Season Brighter in Lewis County

Just as Brian Charneski prepared to make his 2007 Charneski L & E Bottling Co. Holiday Support Fund grants, the now infamous December storms hit. With a long family heritage in Lewis County, Brian immediately knew he wanted to help storm-impacted families. "The devastation was ruthless. Many people were left with nothing at the holidays," he recalls. "We originally set up our fund to be able to respond to those in the greatest need at the holidays, and this storm left so many in need."

Brian selected two Lewis County organizations involved in flood recovery to receive funds: Love INC (Love in the Name of Christ) and Saint Joseph Parish. Both organizations helped local families during the storm's aftermath. Love INC of Lewis County meets community needs through churches. The group used the Charneski donation to immediately purchase building materials for flood victims. Saint Joseph Parish used their contribution to provide free Christmas dinners for local families. "We were able to provide a cheerful atmosphere and lovely hot meal for many families. Donations helped make the holiday season brighter and included gifts for all children in attendance," said Pastoral Assistant Gay Lynn Moneymaker.

"The Community Foundation's flexibility allows me to respond to those most in need each holiday season," Brian notes. "We also support a variety of other causes through The Foundation including high school student scholarships. The Foundation helps me identify where the greatest needs are and which community organizations can best address those needs."



One Donor's Legacy

Collowing a successful legal and corporate career, Kimberly Ellwanger focused her considerable business acumen on philanthropic goals. While she and her husband were conducting routine

estate planning, she discovered that community foundations are set up to ensure her charitable objectives would be met for generations to come. She included The Community Foundation of South Puget Sound in her estate plan, and later established a donor-advised fund.

Upon retirement, Kimberly was invited by board member Lynn Brunton to serve on the board of directors. Kimberly subsequently served eight years on the Foundation's board, including two years as board chair. During her tenure, the Foundation's asset base more than tripled. "My contribution," Kimberly recalls, "was to change the strategic focus of the organization." She credits Foundation Executive Director Norma Schuiteman with taking the Foundation "to the next level and achieving critical mass. Norma is the expert in fund flexibility. She is very experienced and offers advice to help donors structure a charitable endowment that truly meets their goals."

Kimberley was attracted to the flexibility associated with placing her fund under The Community Foundation's stewardship. Her fund, established to benefit women and children, allows her to advise distributions and support preferred causes and organizations. She hopes her daughter will assume a similar advisor role at some point in the future. And, ultimately, she believes The Community Foundation is the best vehicle to direct her funds to her areas of interest if the time comes when her family is no longer involved.

During 2007, Kimberly's fund supported several community causes including SafePlace and the YMCA's Strong Kids Campaign. Her fund, combined with other Community Foundation support, assisted SafePlace in sheltering 311 survivors of domestic violence and their children. Kimberly's empathetic support helped SafePlace provide women with the courage to exit abusive relationships. She notes that their courage is often rooted in "having someplace to go." She believes SafePlace's advocacy and educational outreach programs are critical to promoting broader domestic violence awareness.

Kimberly also actively supports the YMCA's Strong Kids Campaign which offers financial support for a variety of programs families could not otherwise afford. The Kids Campaign generates dual benefits according to Kimberly. "Kids benefit from having safe, solid programs to participate in and learn from the Y's four core values of caring, honesty, respect and responsibility and, their parents derive satisfaction and confidence from giving their children opportunities they might not otherwise afford. The YMCA's Strong Kids Campaign helps kids, but ultimately, the whole family benefits," Kimberly said.

A skilled attorney with an eye toward due diligence, Kimberly's confidence in The Community Foundation's financial oversight and charitable advice makes her comfortable recommending it to others.

"I was recently contacted by friends who saw my name listed on the Foundation's board and called me for advice on setting up a private family foundation versus a fund through The Community Foundation. I suggested they give Norma a call rather than go through the paperwork, registrations and administration a private foundation requires."


