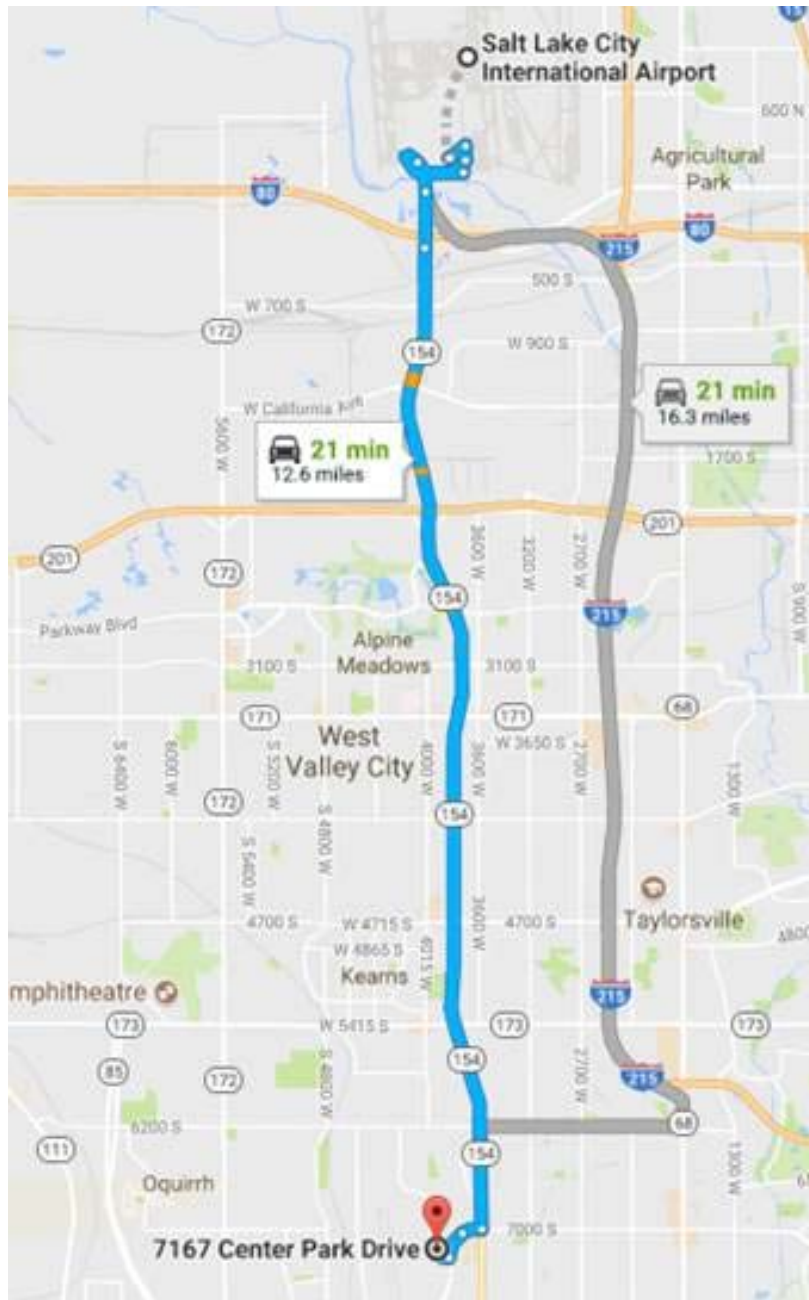


Driving Directions to the Mountain America Tanner Building
Utah Chapter of the ACFE Fraud Conference 10/12-10/13/2017

Driving from the Airport

Directions traveling from the Airport SB I-215.

- Start out going north on N Terminal Dr. toward N 3800 W. Then 0.29 miles
- Take N Terminal Dr. toward Rental Car Return/Pick-up. Then 1.36 miles
- Stay straight to go onto UT-154/Bangerter Hwy. Then 10.66 miles
- Turn right onto W 7000 S. W 7000 S is 0.9 miles past W 6200 S. Then 0.15 miles W 7000 S becomes Jordan Landing Blvd. Then 0.33 miles
- Turn right onto Center Park Dr. Center Park Dr. is 0.2 miles past Cobble Ridge Dr.
If you reach W Center View Way you've gone about 0.1 miles too far. Then 0.12 miles 7. 7167 Center Park Dr., West Jordan, UT 84084-5512.

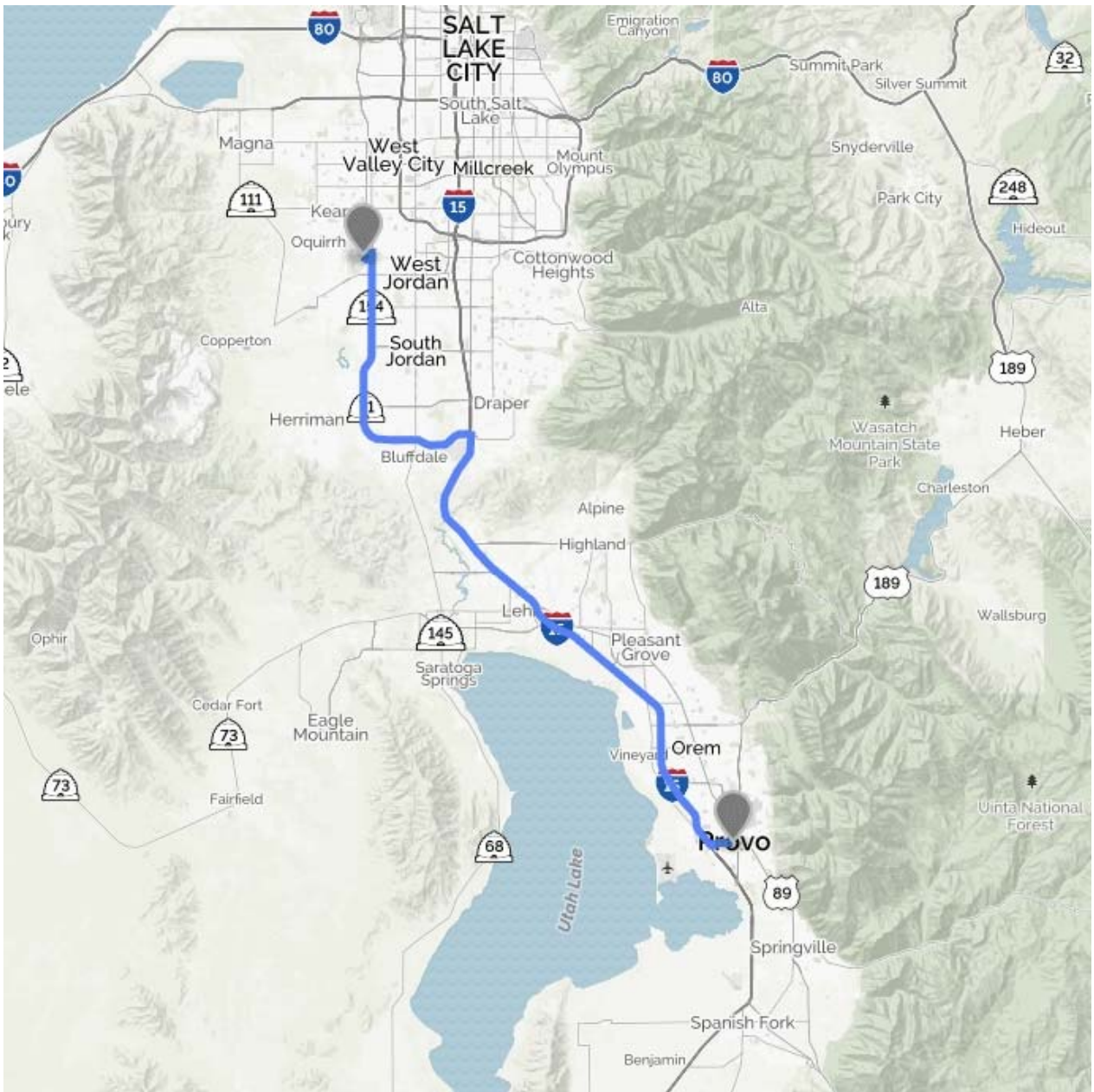

Driving from the South

Directions traveling from Utah County on NB I-15

- Take the Bangarter Hwy exit, EXIT 289, toward Riverton.
- Turn slight left onto UT-154/Bangarter Hwy.
- Turn left onto W 7000 S.
- W 7000 S becomes Jordan Landing Blvd.
- Turn right onto Center Park Dr.
- The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive.

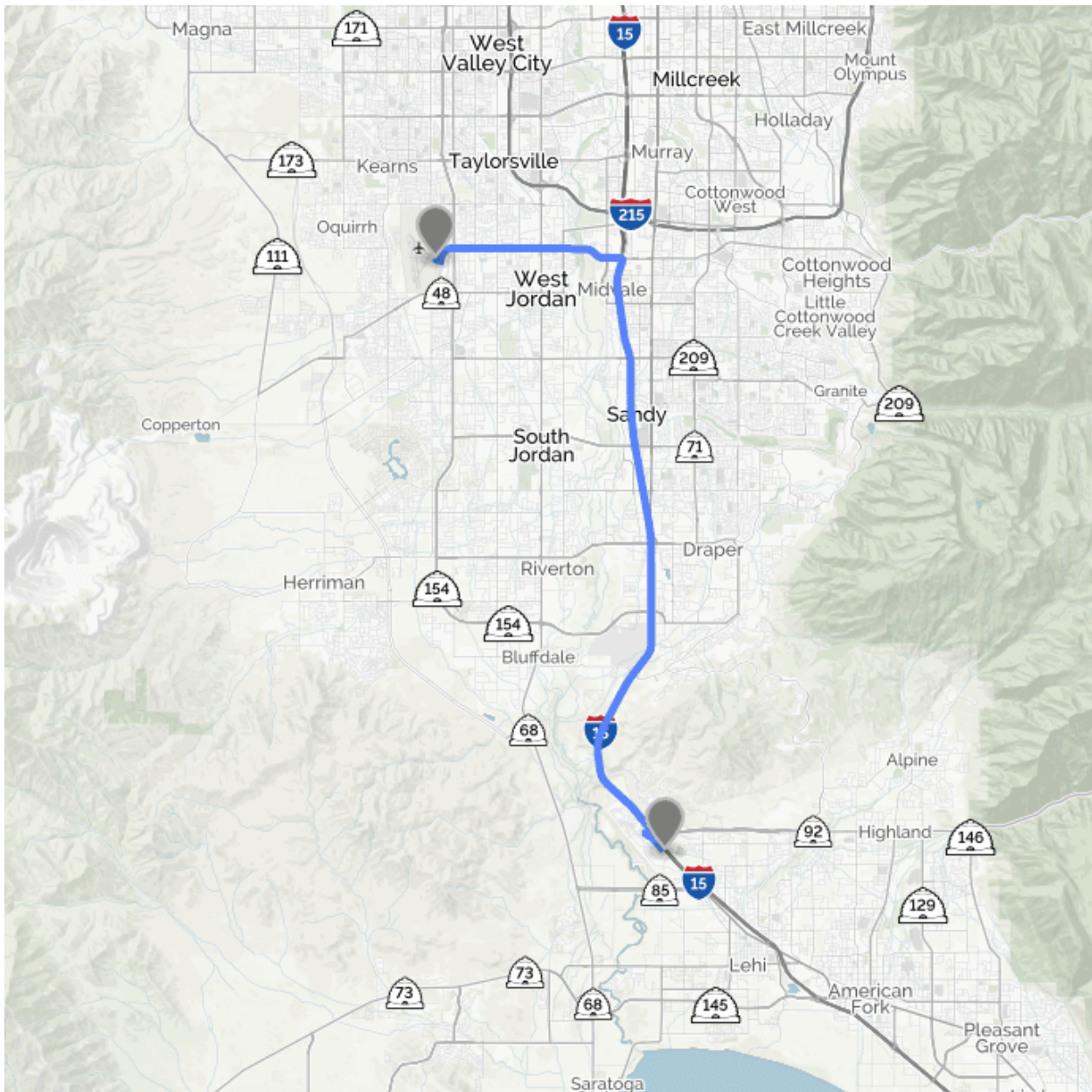

Driving from the South

Directions traveling from Utah County on NB I-15

- Turn Right onto UT-92/Timpanogos Hwy
- Take the UT-48/7200 So. Exit, EXIT 297
- Turn left onto W 7200S/UT-48 continue to follow and it becomes W 7000 S (2.13 miles)
- W 7000 S becomes Jordan Landing Blvd,
- Turn right onto Center Park Dr.
- The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive.

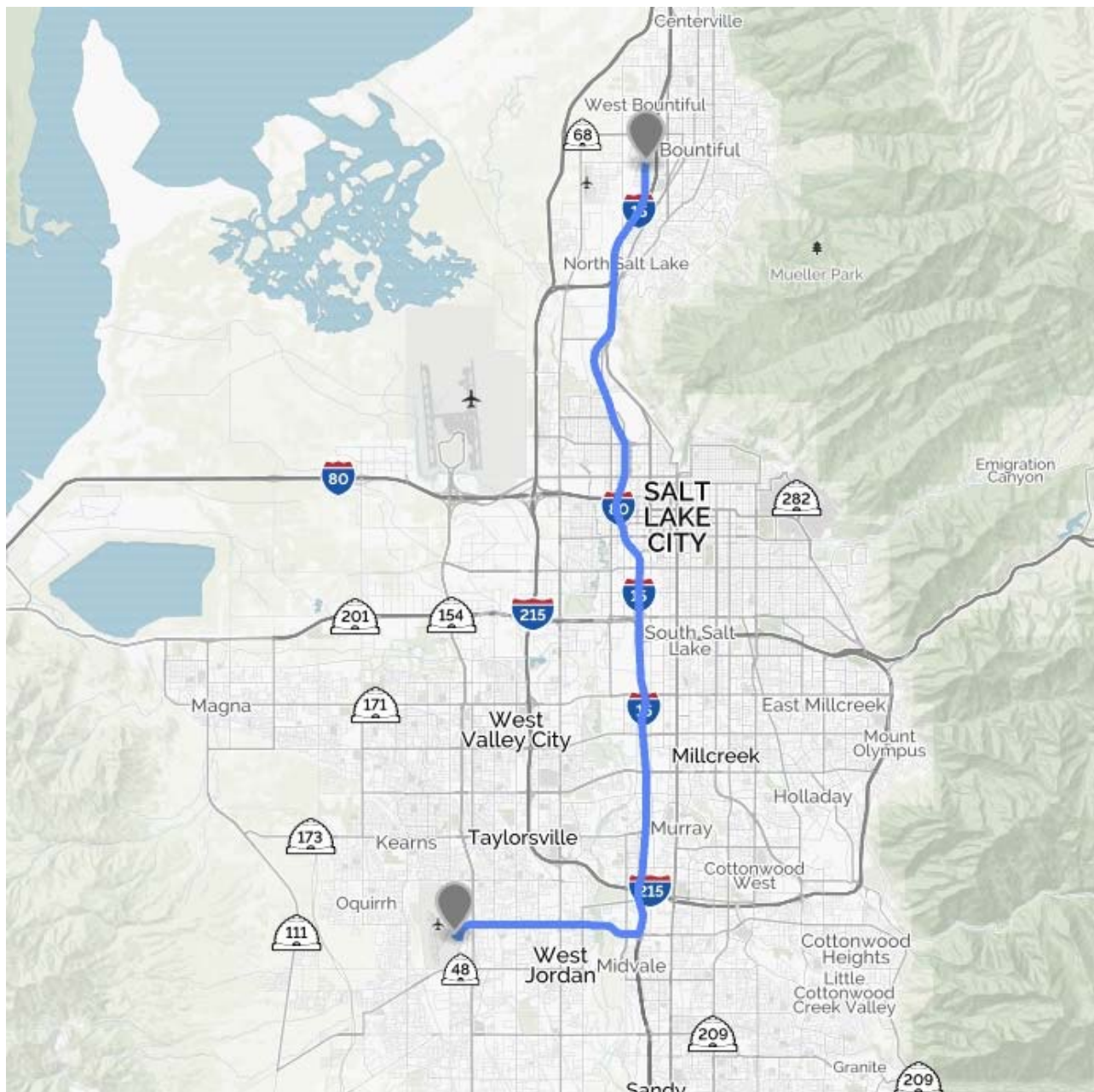

Driving from the North

Directions traveling from Davis County on SB I-15 (from North of Salt Lake)

- Start on I-15 South
- Take the UT-48/7200 So exit, EXIT 297.
- Keep right to take the ramp toward Midvale/West Jordan
- Turn right onto W 7200 S/UT-48. Continue to follow UT-48.
- UT-48 becomes W 7000 S.
- W 7000 S becomes Jordan Landing Blvd.
- Turn right onto Center Park Dr.
- The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive.

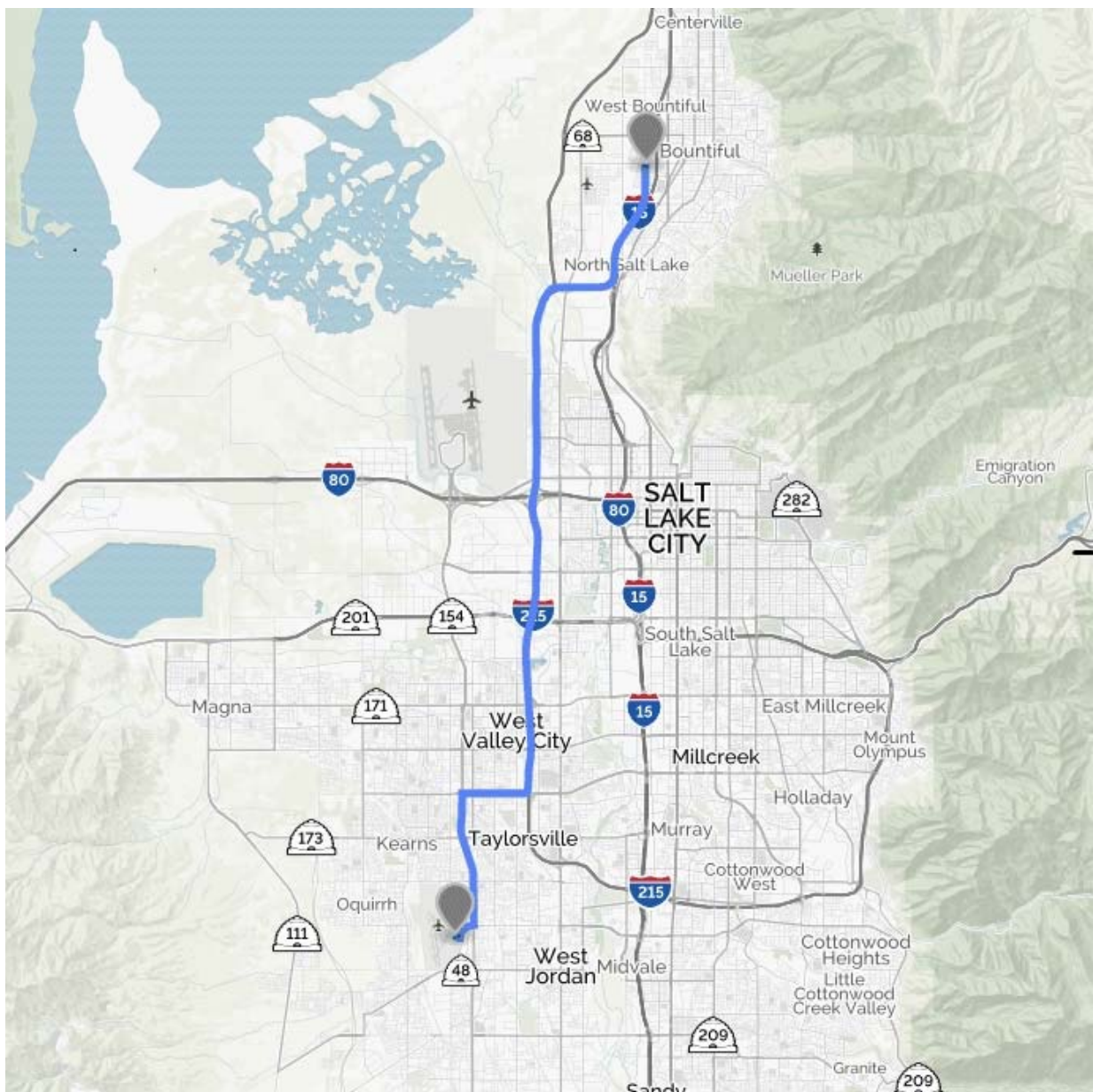

Driving from the North

Directions traveling from Davis County on SB I-15 to I215 (from North of Salt Lake)

- Start on I-15 South
- Take I-215 S via EXIT 313 toward Belt Route/S L Int'l Airport.
- Take the 4700 S/UT-266 exit, EXIT 15
- Turn slight Right onto W 4700S
- Turn left onto Bangerter Hwy/UT 154
- Turn right onto W 7000 S W 7000 S becomes Jordan Landing Blvd.
- Turn right onto Center Park Dr.
- **The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive .**

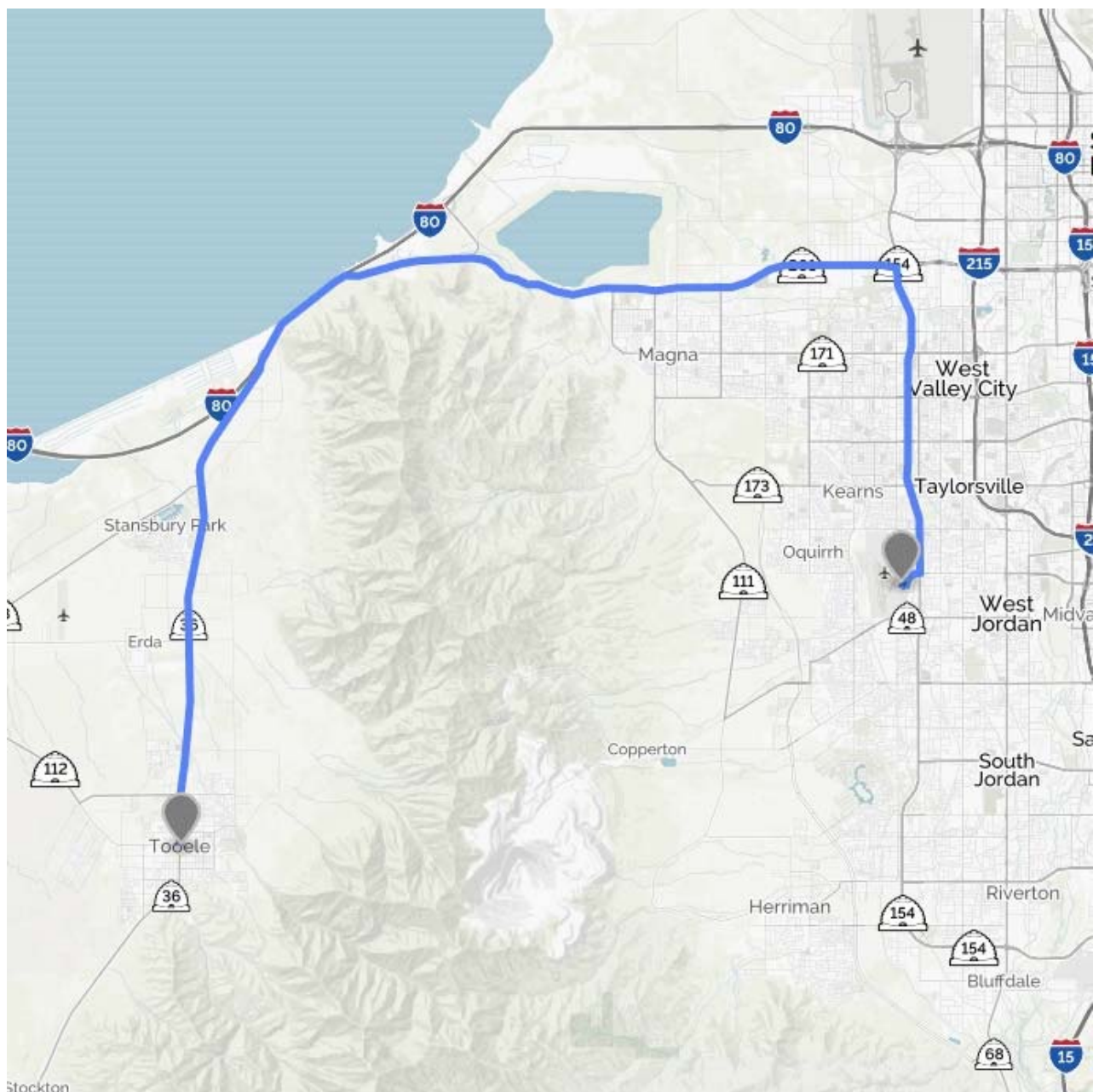

Driving from the West

Directions traveling from Tooele I-80 East

- Take I-80 E toward Salt Lake City
- Merge onto UT-201 E via EXIT 102 toward 2100 S
- Take the UT-154/Bangerter Hwy exit, EXIT 13
- Keep right to take the ramp toward West Valley City. South bound
- Turn right onto W 7000 S.
- W 7000 S becomes Jordan Landing Blvd.
- Turn right onto Center Park Dr.
- **The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive .**

Driving from the East

Directions traveling Salt Lake Millcreek

- Turn Right onto 4500 S/UT-266
- UT-266 becomes W 4700 S.
- Turn left onto Bangerter Hwy/UT-154.
- Turn right onto W 7000 S.
- W 7000 S becomes Jordan Landing Blvd.
- Turn right onto Center Park Dr.
- The Mountain America Corporate Office is on the corner and the Mountain America Tanner Building is directly behind it at 7167 Center Park Drive .
