This Purchase Contract is made between Styled in the Wild Cattery "Breeder" And _____

Purchase contract terms:

1. Purchaser agrees that grading of the cat/kitten is based on the opinion the Breeder at the time of the purchase and will be a sterilized unregistered family pet, or to a breeder left whole. Cat/kitten will never be resold, leased, given away, placed in a shelter, sold to any pet shop, research laboratory, or another cattery. If Purchased by a Cattery, you must stay in good standing with TICA, failure to do so will result in surrender of cat and all offspring. This contract is legally binding to all signing parties and is transferable to other parties upon approval of the breeder.
2. Deposit is non-refundable. You have a choice to pick out your kitten from the available kittens or request to be placed on our list with a grade and look you desire. We will accept a \$500.00 deposit on Grades 1-7, Grades 8-10 require a deposit of \$1,000.00, Grades 10+ require a deposit of \$ 5,000.00 and 10++ require a deposit of \$10,000.00 or more. Once you have paid a deposit Please fill out a contract and send it to the e-mail provided. Once you have committed to specific kitten, we will hold that kitten for you until it reaches 8 weeks and 2 lbs. Failure to pay the final balance or shipping fees (if any) when notified within 72 hr. that it is due will forfeit all payments and all rights to the kitten. Note: your kitten must be paid in full prior to sterilization and arrangements for travel
3. All veterinary care including emergency care is at the Purchaser Expense. Breeder is not responsible for any veterinary expenses incurred by Purchaser at any time. It is advised to obtain health and or medical insurance on the purchase of a Toyger. Purchaser agrees that a kitten entering a home where there is another cat present will be isolated or quarantined until all shots are given to the Kitten. Cat/kitten has been given at least its first 3-way Killed vaccination and any other vaccinations and treatments noted in the medical record provided with this cat/kitten Purchaser also agrees to administer **Killed Vaccines Only!** Failure to do so will void this Warranty.
4. Purchaser agrees that any violation of any terms of this Agreement may result in the surrender of said cat/kitten, and registration/pedigree papers (breeder), to expect no reimbursement of purchase price, deposit, or expense incurred, and Purchaser may be subjected to monetary damages to Breeder, including all cost associated with the repossession.
5. Breeder warrants that this cat/kitten is presented in sound health and not harboring a life threatening genetic disease. In the event the cat/kitten should die for any reason or be stolen within the first-year warranty period, despite medical treatment, or extensive searching if Stolen, The kitten will be replaced at Breeder's discretion with similar quality cat/kitten when one becomes available. Purchaser must notify Breeder immediately and obtain, at his/her expense, an official autopsy report with pertinent lab findings indicating cause of death, or a detailed police report stating the kitten was stolen and where the theft occurred and how. Purchaser agrees to pay only 5% of the purchased price, sterilization, chip, and shipping of the replacement kitten.
6. Breeder agrees to replace your Toyger if its death is attributed due to a genetic defect that we could have easily prevented with a more stringent genetic screening and breeding practice. The kitten will be replaced at Breeder's discretion with similar quality cat/kitten when one becomes available, Purchaser agrees to pay only for the sterilization, chip and shipping of the replacement kitten. and a 20-year prorated amount of the purchase price, of 5% every year that the cat was alive.
7. If it becomes necessary for Purchaser to give up the cat/kitten for any reason, Purchaser will contact Breeder, who has the FIRST right of refusal to take ownership without compensation of the cat/kitten or will assist in finding a suitable new home for the cat/kitten. This right is not time limited, but remains in effect for the life span of the cat/kitten and to any new owner. Under no circumstances is cat/kitten to be placed with a different home / owner or cattery, resold, leased out, traded, or given to any other person, pet shop, animal shelter, research laboratory, or similar facility for whatever reason or purpose without Breeder's knowledge and written consent.

8. Purchaser agrees to care for this cat/kitten by providing proper love, attention, nutrition, Cat/kitten will not be caged as a primary living arrangement. Breeder reserves the right to inquire about and reasonably inspect the cat/kitten's housing and quarters. Purchaser agrees that this cat/kitten shall be kept indoors only. The cat/kitten is allowed outdoors only upon a leash, with the cat/kitten kept separate from all other outdoor animals. Breeder reserves the right to repossess, with no compensation to the owner if cat/kitten is found in an unsanitary or inhumane condition, or being caged.
9. Purchaser agrees to allow the Breeder the right to use his/her cat/kitten's photograph, video, or name in future or existing advertising without remuneration or credit.
10. If shipping arrangements are being made, Purchaser is responsible for all shipping related charges (including a health certificate and Id Chip) and these costs shall be paid by the Purchaser to Breeder in full prior to Breeder's transfer of cat/kitten. If the delivery is made by Breeder directly to Purchaser, a delivery fee may apply and shall be paid in advance of delivery. There shall be no refunds of purchase price, shipping charges, or any other costs. Buyer is responsible for subsequent delivery fees upon replacement.
11. Any claim under this health guarantee will require submission of veterinary records of the cat/kitten along with records for all other household pets the cat/kitten was exposed to, including but not limited to complete medical records, necropsy, necropsy report, x-rays, written certification of cause of death and return of registration papers. Claims are subject to verification by Breeder's veterinarian. Breeder reserves the right to require the cat/kitten be returned for identification before providing a replacement. This contract serves as permission and right to obtain any or all medical records for all pets in owner's household. No replacement can be made if other existing cats have a serious contagious disease. Breeder reserves the right to ask for specialized testing of other cats that the cat is exposed to.
12. In the event of invalidation of any provision of this contract, the remaining provisions of this contract will continue to be fully enforceable in accordance with the terms within. All legal fees and/or court costs necessary to enforce this contract will be the obligation of the Purchaser, including all those incurred by the Breeder. Any legal action which may arise under the terms of this contract will be brought in the city/county of Breeder's residence
13. A facsimile or e-mailed copy shall be enforceable as an original if the original contract is lost, destroyed or otherwise unavailable. By Payment of deposit the Purchaser acknowledges and accept the terms all parts of the Contract.
14. This legally binding contract is the exclusive agreement between the Purchaser and Breeder and supersedes any and all prior oral or written agreements. This agreement may be modified only in writing, signed by both Purchaser and Breeder, and is non-transferable to any other party unless approval of the breeder. All additions and changes to the Agreement must be initialed by both parties. This contract is binding and enforceable on the purchase of the cat/kitten and any replacements. Purchaser acknowledges that there are no cash refunds associated with this Agreement and Deposits are non-refundable. This contract covers the purchased cat/kitten and any and all replacement cats or kittens.
